Deposit & Payment: A deposit of 50% of the annual pass fee is required before privileges begin. The remaining balance of 50% is due by March 1st. If these terms are not met, Lederach Golf Club is released from any and all obligations under this agreement and the pass holder forfeits any fees paid. All passes are payable by cash, check, VISA, Master Card or American Express. If American Express is used, an additional 2% fee will be assessed.

LEDERACH GOLF CLUB GENERAL ANNUAL PASS AGREEMENT TERMS AND CONDITIONS

General – All passes are nontransferable and all memberships are nonrefundable. Lederach Golf Club reserves the right to change pass programs and pricing at any time. Passes do not convey any ownership rights and/or privileges beyond what is outlined in this package. Access to the golf course is subject to availability.

Pass Holder Initials

Refusal of Privilege – Lederach Golf Club shall have the right to refuse golf course privileges to anyone who is judged to be in violation of the established rules and regulations herein. See rules and policies attachment.

Pass Holder Initials

Charging Privileges - All pass holders are entitled to charging privileges for Golf, Food & Beverage, Merchandise and any other services provided by Lederach Golf Club. Charging privileges will begin once the 50% deposit is received. If you are 30 days late in payment, charging privileges are immediately revoked. If you are 60 days late in payment, your pass holder privileges will be suspended until account is paid in full. By signing this terms and conditions sheet, the pass holder agrees to be responsible for all charges including Golf, Food & Beverage, Merchandise, and other services provided by Lederach Golf Club. Statements are sent the first week of each month for prior months charges and are due in full by the end of the month.

Pass Holder Initials

No Show & Cancellation Policy - All pass holders, regardless of his/her category, must provide notice to the golf shop at least 24 hours in advance if they cannot make their scheduled tee time. If a pass holder does not attend a reserved tee time, and does not cancel their tee time at least 24 hours in advance, they will be charged a \$20 no-show fee. The charge will be posted to the account of the pass holder who made the tee time. Groups that habitually no-show (More than 3 times) will be subject to suspension. Lederach Golf Club reserves the right to pair all singles, twosomes and threesomes. When reserving tee times, pass holders are responsible for the number of players booked.

Pass Holder Initials

Guaranteed Tee Time Policy– All Guaranteed Tee Times must fall with the following time frames: Saturday Mornings: Open - 8am. Sunday Mornings: Open - 8am. Guaranteed tee times start March 29, 2008 and end October 26, 2008. Lederach reserves the right to move guaranteed tee times up to 45 minutes earlier or later based on sunrise schedules with 15 days notice. In the event of an outing, other arrangements for play will be made.

Pass Holder Initials

Limitation of Liability – Lederach Golf Club will not be liable for any lost profits or for any indirect, incidental, consequential, punitive or other special damages suffered by the player arising out of or related to this Agreement even if Lederach Golf Club has been advised of the possibility of such damages. In no event shall the total cumulative liability of Lederach Golf Club in connection with the Agreement from all causes of action of any kind (including tort, contract negligence, strict liability, breach warranty and fundamental breach) exceed the total amount paid by the player to Lederach Golf Club under this Agreement.

Indemnification – The player will defend, indemnify and hold Lederach Golf Club, together with the parent companies, subsidiaries and/or affiliated companies and the shareholders, officers, directors, partners, members, manager, employees, agents, consultants, representatives and attorneys of all foregoing and their respective heirs, executors, administrator successors and assigns (collectively, "Lederach Golf Club") harmless from and against any or all losses, damages, claims, costs, suits, actions, judgments, liability and expenses including responsible counsel fees and expense resulting from or arising out of any claim to personal injury or death resulting from services Lederach Golf Club shall render. This indemnity shall survive any termination of the agreement.
