NO REFUNDS

Photo ID badges will be issued this year. There is no charge for your first badge, but there is a \$10.00 replacement fee. The ID must be presented at the front gate upon entering the pool area. Badges are NON-TRANSFERABLE and must be worn on the pool premises at all times. Failure to display, or produce your badge upon request by pool personnel, could mean expulsion for an indefinite time. WHEN SOMEONE IS FOUND TO BE USING SOMEONE ELSE'S BADGE, BOTH PARTIES MAY BE RESTRICTED FROM ALL POOL PRIVILEGES FOR THE REMAINDER OF THE SEASON. We encourage parents/guardians to explain this policy and the penalty to their children.

Applications may be mailed in, but since photos must be taken for the ID badges, each individual is required to pick up their badge in person. Applications will be accepted, and photos taken, at the pool office in May as follows:

Tuesday May 11th and 18th from 6-8pm
Thursday May 13th and 20th from 6-8pm
Saturday May 15th and 22nd from 1-3pm

The pool will open for the season on Saturday, June 12th. Badges may also be processed during normal pool hours. Please note the new regular pool hours are from 12:00pm - 8:00pm Monday - Saturday, and 12:00pm - 6:00pm Sunday. Hours are subject to change.

Swim lessons will be available to members only at \$40.00 per session, beginning on June 21st. Sign-ups for the first session of lessons will begin on Wednesday, June 16th at 2:00pm.

The pool closing date will be determined based on staff availability but no earlier than September 1st and no later than September 6th. The pool will be closing early for scheduled swim meets. Dates will be posted accordingly.
