DEFINITIONS

PEDDLE – To carry from place to place and sell; sell or deal out in small quantities.. generally, the offering of tangible goods for sale by traveling door to door.

SOLICIT – Make appeals or requests, try to obtain orders or business. Generally, door to door personal contacts in an effort to obtain opinions, donations, support and/or other tangible things. May include the solicitation for future delivery of tangible goods.

TERMS, CONDITIONS AND RESTRICTIONS

Note: In the following paragraphs, the term "soliciting" shall be understood to include both soliciting and peddling activities.

- 1. Each individual desiring to solicit must complete a separate form.
- 2. Each applicant must provide a copy of their own criminal history report from the applicant's home state. This report cannot be more than 6 months old.
- 3. Soliciting can only occur between 9:00AM and dusk.
- 4. Soliciting permits are valid for 3 months from date of issue.
- 5. The application must be completed in full, dated and signed.
- 6. The receipt (permit card) issued by the Police Department upon completion and approval of the application form MUST be carried on the registrant's person while he/she is engaged in the soliciting activity. It must be displayed to any resident or any police officer upon request. Receipts/permit cards are NOT transferable.
- 7. The applicant voluntarily agrees to a background check to include, but not be limited to, a driver's license status and local police department check of municipalities where the applicant resides. Applicant also understands that his/her fingerprints and a photograph will be taken as part of the application process.
- 8. Applications may be denied if an applicant's background reveals a criminal record that indicates a potential threat to the health, safety and welfare of the residents.
- 9. Registrants are not permitted to solicit beyond the scope of purpose outlined in the application.
- 10. No solicitations may be conducted via any vehicle other than that described in the applicant's application form unless the police department has been informed in advance.
- 11. The registrant is not permitted to "hawk or cry" his goods, services, etc. upon any street or sidewalk, nor to use a loudspeaker, "bull horn" or other device for announcing his/her presence upon or along the streets or sidewalks of the township.
- 12. Registrant may not conduct his/her business from a vehicle parked upon or along any street or alley in the township, except for the time necessary to specifically service the residents of the immediate vicinity.
- 13. The privilege of soliciting, along with the receipt/permit card, may be revoked by any police officer for:
 - A. Misconduct of registrant
 - B. False statements on the application form.
 - C. Violations of any of the above conditions and restrictions
 - D. Violation of any state law or township ordinance
