#### Dear Residents::

Good riddance to cold temperatures and inclement weather and welcome warmer weather and outdoor activities - As the years mount, my appreciation of nice weather has increased dramatically.

Much has been happening in the township since my last writing and all seems for the benefit of the township residents. As one example, in late January, the Delaware Valley Trusts' Executive Director and Risk Control Department staff selected a winner from the risk management innovation award applications received over the course of 2023. This recognition program seeks to celebrate "out-of-the-box" problem solving. We were delighted to find out that Lower Salford Township Public Works was selected to receive the 2023 award for their submission titled, "Home-Brewed Damage-Resistant Vehicle Camera Mounts".

Lower Salford's Public Works Department installed cameras on their plow trucks to ensure safer backing maneuvers as well as make it easier/safer for drivers to view truck bed salt levels. This remote viewing eliminated the need for drivers to periodically stop plowing and climb up onto the truck bed to view its contents. In recognition for winning the 2023 DVT Risk Management Innovation Award, DVT celebrated Lower Salford Township Public Works with a recognition plaque, catered luncheon for the team, and \$1,000 prize to help with project expenses. Our collective congratulations for this honor.

Other notable projects on the horizon for the township include a few infrastructure improvement projects as follows:

- A project to install concrete sidewalks along Main Street from Ruth Road up to the new Wawa & Mainland Pointe, in which the township received Grant Funds in the amount of \$985,000.
- Sidewalk along Yoder Road between Kulp & Vernal Lane Connect to existing sidewalk near the middle school soccer fields. Grant Funds were also received for this project.
- Roth Park Upgrades level play area, replace fencing, remove trees, added a railing, additional parking spaces
- The installation of cameras in several parks: Heckler, Roth, Reiff, Camp Wawa. Working on getting others included.

As is customary this time of year, also affectionately known as "Construction Season", we would like to remind those traveling to be extra vigilant in construction zones as our Public Works employees are some of those construction workers working to improve our path of travel. Wishing everyone happy and safe Spring/Summer 2024 wherever your path takes you!



### **PROPERTY MAINTENANCE CODES**

Be advised that the Township adheres to the **BOCA National Property Maintenance Codes**. These codes are extensive, but several are commonly referred to in the warmer months when plants begin to grow and residents start to walk about. Below are a few of the Property Maintenance Codes.

- **PM-303.1 Sanitation:** All Exterior Property and premises shall be maintained in a clean, safe and sanitary condition. The occupant shall keep that part of the exterior property which such occupant occupies or controls in a clean and sanitary condition.
- **PM-303.3 Sidewalks and Driveways:** All sidewalks, walkways, stairs, driveways, parking spaces and similar areas shall be kept in a proper state of repair and maintained free from hazardous conditions. Stairs shall comply with the requirements of Sections PM-304.10 and PM-702.9.
- **PM-303.4 Weeds:** All premises and exterior property shall be maintained free from weeds or plant growth in excess of 10 inches (254mm). All noxious weeds shall be prohibited. Weeds shall be defined as all grasses, annual plants and vegetation, other than trees or shrubs provided; however, this term shall not include cultivated flowers and gardens.



### **TROUT STOCKING FUN!**

The rain held off for this year's annual trout stocking, allowing local children the opportunity to help "stock the pond" at Roth Park. Each year, the Township stocks rainbow trout over 3 separate area ponds prior to fishing season: Briarwyck Pond, Alderfer Road Pond and Dan Roth Park Pond (affectionately known as the "Duck" Pond). For decades the Township has contracted with Limestone Springs Preserve out of Richland, Pennsylvania to provide the trout for the ponds. To help stock this year, Paula Mandracchia's Seasons Class at the Souderton Charter School Collaborative participated, as well as much younger participants from the YMCA Preschool program in Harleysville. Children were able to literally "catch a fish in a barrel" and take the fish by net to the pond where members





of the Township Public Works Department assisted in the fish transfer to their new home at Dan Roth Park Pond. The Township would like to thank Eric of Limestone Springs who made a brief presentation to both groups of youth about the Preserve, as well as: PA One Call, North Penn Water Authority, Perkiomen Watershed Conservancy, Sips & Berries and Wawa all who donated items for the children to take with them; and Tractor Supply who donated the use of the stock tanks for the fish. Last but not least, a big thank you to the Township Public Works Director, Doug Jones, for organizing this event, as well as his crew who set everything up and assisted the children with the transfer of trout. Everyone helped to make this a great day of fun and learning!

### **Township Receives Environmental Stewardship Award** from Montgomery County



The Township was recently honored by the Montgomery County Board of Commissioners for the Jacob Reiff Park Stream and Floodplain Restoration Project. Along with the Perkiomen Watershed Conservancy, the restoration project spanned almost 2 years of hard work in designing, planning, implementing, and completing this project that improved the ecosystem of the stream and the surrounding lands. Many

thanks go out to Ryan Beltz, Director of the Perkiomen Watershed Conservancy for having the foresight of this much needed project as well as his team in applying for and receiving grant funds, CKS Engineers, the Township Engineer's Office, for designing the improvements and the Township Public Works Director Doug Jones and his team for their help in coordinating and doing the bulk of the physical labor. The Township is humbled by the recognition and encourages everyone to visit Jacob Reiff Park or any one of the 12 parks in the Township.

### **JACOB REIFF PARK STREAM RESTORATION – PHASE 2**



The Township completed the first phase of stream restoration at Jacob Reiff Park in 2022. The project was a joint effort with Perkiomen Watershed Conservancy (PWC), CKS Engineers and Lower Salford Township. The project was located along the West Branch of Skippack Creek just north of the historic farmhouse and barn. The steep banks of the stream were lowered which allowed for the reconnection of the creek with the adjoining floodplain. A large rain garden area was constructed within the floodplain area to allow for infiltration and plant uptake and to provide improvement of the water quality in the stream. The first phase of the project received the 2023 Governor's Award for Environmental Excellence and 2023 Environmental Stewardship Award from Montgomery County.

Lower Salford Township is required by the Environmental Protection Agency (EPA) and the Pennsylvania Department of Environmental Protection (PADEP) to reduce sediment and nutrients in several streams in the Township. To continue with this effort, the Township is teaming up with the PWC and CKS Engineers to pursue grants for Phase 2 of the Jacob Reiff stream restoration project. The



next stream section to be addressed is downstream of the first phase, just south of the historic farmhouse and barn. The Phase 2 project will be similar to the first phase and will address the eroded stream banks and provide for floodplain reconnection. In addition, a severely eroded drainage channel that carries runoff to this section of the stream will be regraded and stabilized. Riparian buffer plantings will be provided along both sides of the stream and the floodplain area will contain low lying rain garden areas.

The design for Phase 2 is underway and the PWC is assisting the Township in applying for grants to complete the work. Stay tuned for future updates on the project and volunteer opportunities to assist with the planting when the time comes. PWC will be coordinating the volunteer efforts so if you are interested in volunteering, watch the PWC website to see when volunteers can sign up to help.

This project is one of several projects in the Township to address the water quality in our streams and to comply with the Township's permit from the PADEP. Keep watching the Township's news to learn about future projects.

### Safety Updates to Roth Park

You may have noticed more activity than usual at the "Duck Pond" on Maple Avenue behind the Harleysville Hotel. This is Daniel Roth Park and upgrades are currently happening to provide a safer and cleaner environment for all who visit (including the ducks!). The Township Public Works Crew has been busy removing 2 sweet gum trees near the parking area that have caused damage to not only the path with root eruptions, but also the pond as branches have started to fall into and around the pond.

Upgrades to the playground are also happening as the area will be graded to a more level surface making for a safer play area for little ones, and the fence is being replaced around the play structure as well. Years of patrons backing into the adjacent parking spaces have damaged the fencing, and therefore is being relocated further back and replaced.



Dan Roth is one of the Township's busier parks, and therefore a few additional parking spaces will be added as well. All these upgrades are happening to create a safer and healthier space for all. Thanks to everyone for their patience!

### **DROP OFF GUIDELINES**

- Montgomery County events are following state guidelines and public health restrictions.
- Leave items at home that are not for the event so that they are not removed accidentally.
- If you need your gas can or container returned, please tape a note to it stating that you want to keep it.
- You may arrive any time within your registered appointment window.
- Please print out your ticket or write your name and appointment time on a piece of paper.
- If you cannot attend the event, please cancel your appointment through your Eventbrite ticket or by emailing Recycling@ MontgomeryCountyPA.gov, as others may be waiting for an opening.
- NO TVs, electronics, or appliances will be accepted.
- Event workers will unload your materials so please remain in your vehicle.
- BUSINESSES AND CONTRACTORS WILL BE TURNED AWAY, no commercial/industrial waste accepted.
- Bring all substances in original containers with labels. Items must be identifiable. Do not mix materials.
- Tighten lids on all containers. If containers are leaking, pack in larger container with newspaper to soak up leaks.
- NO 25- OR 50-GALLON DRUMS ALLOWED. Five-gallon buckets are the largest acceptable container. Maximum amount accepted per vehicle is 25 gallons or 220 pounds.
- There are no permanent drop off locations in the region for household hazardous waste, only the listed collections.

### Township Wins Risk Management Innovation Award for 2023

In late January, the Township's insurance provider, Delaware Valley Trusts (DVT) Executive Director and Risk Control Department staff selected a winner from the risk management innovation award for applications received over the course of 2023. This recognition program, which selected its first winner in 2011, seeks to celebrate "out-of-the-box" problem solving by both DVT Property Liability and Workers Compensation members. We are very pleased to announce that Lower Salford Township was selected to receive the 2023 award for the "Home-Brewed Damage-Resistant Vehicle Camera Mounts"!



Lower Salford's Public Works Department decided to install cameras on their plow trucks to ensure safer backing maneuvers as well as make it easier/safer for drivers to view truck bed salt levels. Remote viewing eliminated the need for drivers to periodically stop plowing and climb up onto the truck bed in order to view its contents. It was determined that the relatively sensitive video cameras would need to be protected from potential damage, especially during loading



operations. Township Public Works Employee, Steve Delikat, skillfully fabricated a robust camera housing from stock stainless steel square tubing. The resulting "armored" housing protects the camera from physical abuse as well as corrosive environments. An elegant solution to a real-world operational concern! Congratulations, Steve!

In recognition for winning the 2023 Risk Management Innovation Award, Delaware Valley Trusts and the Township celebrated with a catered luncheon for the project team as well as a recognition plaque, along with a \$1,000 prize to help with project expenses.

### **TEMPORARY SIGNS:** Township Adopts Revised Ordinance

The Township recently adopted Ordinance 2024-02, which establishes new regulations for temporary signs. Once permitted, signs may be displayed up to a maximum of 30 consecutive days, three times per year, with the date of display written on the face of the sign. One or more temporary signs are permitted on a property so long as the total of all signs does not exceed 24 square feet. There are additional limitations listed in the full ordinance pertaining to duration, amount, and size of temporary signs. It is important to know that temporary signs are regulated based on each property in the Township, not each separate business (coordination with other tenants and the property owner is encouraged). If the date is not written on the face of the sign, or if the signs do not comply with the code, then they are subject to immediate removal by the Township. The Lower Salford Township Police Department would like to supply several tips as the summer months approach, as well as encourage residents to take a few precautionary steps to ensure a safe summer. As families plan for vacations, they should know the police department provides security checks of the exterior of the home while residents are away for extended periods of time. Residents can complete a vacation check request through the township website or they can stop by the police station and complete the information in person. While away, please remember to always contact the post office to have mail delivery put on hold. Residents should also suspend newspaper deliveries and have a trusted neighbor or family member take trash cans away from the curb so that it does not appear that you are away from home.

Additionally, as the weather starts to get nicer, residents can expect to start seeing solicitors at their door. Soliciting is permitted under the law so long as the individual(s) come to the police department and completes the Soliciting Permit Vetting Process. Valid/approved solicitors must wear/display their issued Lower Salford permits so it can be clearly read. Do not be afraid to ask to see the individuals' permit. When in doubt, please contact the Lower Salford Township Police Department so we can verify the solicitors are approved. Soliciting is not permitted after sundown, so you should not expect late visitors to your home.

Please, always remember there are Police Officers on duty 24 hours a day, 365 days a year. The Police Clerk/Office hours are 8:00 a.m. to 4:30 p.m. The Lower Salford Township Police Department wishes you a safe and happy summer and feel free to contact our office with any questions or concerns.

### When You Go On Vacation: Tips for Securing Your Home

Summer is a time when many residents will be leaving home for extended periods of time. A vacant home is an attractive target for thieves. Here are a few steps you can take to secure your home:

#### Make doors crime resistant

Install deadbolt locks, solid doors and sturdy hinges and strike plates. (Be sure all materials meet building and fire codes.)

#### Secure sliding doors

- Install locks to prevent sliding or lifting.
- Drill a hole through the inside frame and insert a nail to prevent sliding.
- Place a strong piece of wood in the track.

#### Safeguard valuables

- Engrave TVs and other household valuables with some identifiable number or label.
- Rent a safe-deposit box for small valuables.

#### Prevent window entry


- Use window key locks. Keep keys in locks for quick exit in case of emergency or fire.
- For double-hung windows, drill holes downward where inside and outside sashes meet. Insert nails or bolts.
- Consider grates for basement and first floor windows. (Check ocal fire codes first.)

#### Crime-proof outside areas

- Keep yard, porch and entrances well lit. Look into motion detection lighting.
- Store tools, toys, etc., after use.
- Never hide keys outside your home.
- Keep bushes trimmed near doors and windows.

Have peace of mind when you're away. Inform a trusted neighbor of travel plans. Have him or her collect mail and other deliveries. Don't share your plans with strangers.Leave shades in their normal positions. Have police conduct security checks on your home while you are on vacation.

### Freedom Valley Medical Rescue (FVMR) - Spring 2024 Update

Freedom Valley Medical Rescue remains a strong and vibrant Emergency Medical Services (EMS) organization considering the current EMS crisis within the State of Pennsylvania that has caused many to close their doors; thanks largely to the support from Lower Salford and Limerick Townships.

This municipal partnership is essential; their committed support is strengthening our operations to ensure highlevel services can be provided to the community for many years to come.

Since the beginning of this year, FVMR has been able to move forward with the following important initiatives:

- An expansion of the FVMR Board of Directors, who bring ideas and business expertise on how best to meet the challenges facing the EMS industry.
- Stabilization of the annual operating budget to address funding challenges that continue to occur due to declining insurance reimbursement payments.
- Reorganization of on-duty personnel to ensure all crews are properly staffed to answer the increasing number of calls for service.
- Long-range budget planning for the purchase of state-of-art equipment, tools, and vehicles to ensure that our medical personnel are properly equipped to save lives.

FVMR is committed to finding solutions, such as our municipal partnerships, to adapt as legislative changes affect all Pennsylvania EMS organizations. In addition, our long-range budget planning will enable us to be proactive and ready for growth as advances in medicine and technology continue to generate changes in operations and the protocols for emergency care provided by EMS.

FVMR is quickly becoming a leader in our region on how to best adapt to the many challenges in providing EMS to the great communities we serve, and we could not be more proud of how far we have come already.







### **GRANT FUNDING WRAP-UP:** Winding our Way to Infrastructure Improvements

Lower Salford Township continually looks for ways to improve its infrastructure through grant funding opportunities each year that allows it to make the best use of its local dollars. These grants vary in their program guidance and include both new projects such as trail and sidewalk connections, as well as maintenance and upgrades to systems such as traffic signals that are the Township's responsibility.

Over the past year, the Township has been awarded nearly \$1.25 million towards a variety of infrastructure improvements. More funding applications are awaiting award decisions and the Township will continue to pursue these opportunities in support of its local community. A summary of Grant Funding received over the past year:

- *PennDOT Green Light-Go (GLG) Grant:* Lower Salford Township regularly submits applications for funding to upgrade traffic signals and systems within the municipal boundary. In 2023, Lower Salford was awarded **\$358,499.20** of funding for the Main St. Adaptive Traffic Signal Control System Upgrade
- *PennDOT Automated Red-Light Enforcement (ARLE) Grant* is another program that focuses on safety improvements, especially crash reduction. In 2023, the Township received an award of **\$86,200** for striping and signage upgrades to Indian Creek Road, Groff's Mill Road, Sturgis Road, Bob Bea Lane, Moccasin Drive, Yoder Road, Maple Avenue, Kulp Road and Lucon Road. The Township expects to implement these improvements in 2024 during the annual road maintenance operations.
- Department of Community and Economic Development/Commonwealth Financing Authority (DCED/CFA) Greenways Trails and Recreation Program (GTRP) \$200,000 awarded in 2024. These grant funds will be used to install the Yoder Road Sidewalk Connection Project located between Kulp Road and Vernal Lane. The project is also seeking funds from the 2024 Montco2040 Grant program to use towards the remaining construction cost.
- Department of Community and Economic Development/Commonwealth Financing Authority (DCED/CFA) Multimodal Transportation Fund (MTF) Program. The Township was recently awarded \$600,000 to advance the project development phase of the PA 113 Alternate Route and Shared-Use Path Project.

The Township will continue to pursue these and other opportunities in support of our local community. If you have questions about these grants, please contact the Township Office for additional information.
